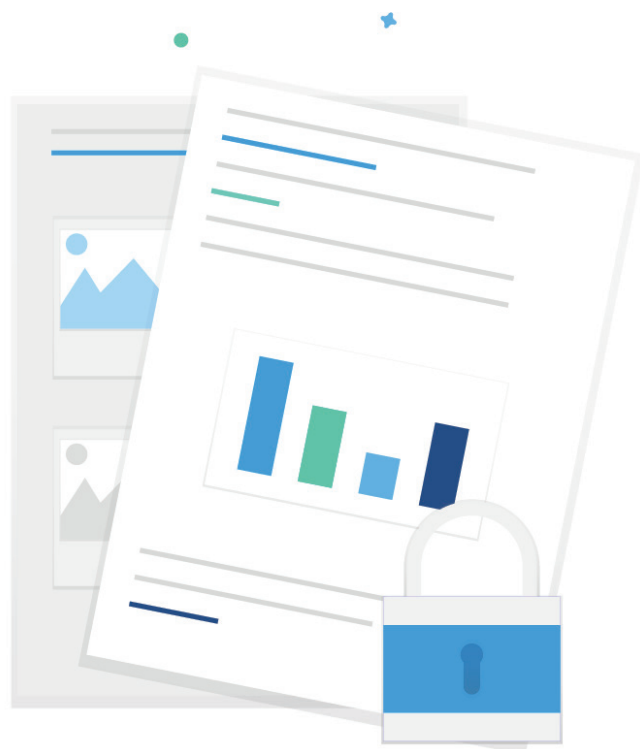

- 3) A blank database will need to be created on SQL Server.
